### Practitioner

For both new and experienced practitioners who have completed training in men's family violence and observed men's behaviour change group sessions.

*This can be demonstrated by providing either:*

- Record of current or previous work in the specialist men's family violence field; or
- Graduate Certificate in Male Family Violence and record of having observed four or more MBC group sessions; or
- Certificate of completion of NTV Introduction to Men's Behaviour Change short course *and* record of having observed four or more MBC group sessions.

### Advanced Practitioner

For practitioners with a recognised qualification and current or recent experience in the specialist men's family violence field, including facilitating MBC groups.

*This can be demonstrated by providing either:*

- Graduate Certificate in Male Family Violence; or
- Bachelor's Degree (or higher) in Social Work, Psychology, or equivalent;

*And both of the following:*

- Record of having worked in the specialist men's family violence field for at least two consecutive years, including within the last three years; and
- Record of having co-facilitated at least 50 MBC group sessions.

### Supervisor

For practitioners with extensive experience and training in providing supervision.

*This can be demonstrated by providing either:*

- Graduate Certificate in Male Family Violence; or
- Bachelor's Degree (or higher) in Social Work, Psychology, or equivalent;

*And all of the following:*

- Record of having worked in the specialist men's family violence field for at least five years, including within the last three years; and
- Record of having co-facilitated at least 100 MBC group sessions; and
- Record of having completed recognised supervision training

## Membership agreement

I, \_\_\_\_\_ support the aims of No to Violence (NTV) and agree to comply with the Rules of the Association<sup>1</sup>. I agree to support and/or work in line with the following principles for specialist men's family violence work:

1. Victims/survivors' freedom and safety underpins all interventions with men who use family violence.
2. Specialist men's family violence work demonstrates an understanding of the dynamics of family violence and is informed by the needs of victims/survivors, including children.
3. Specialist men's family violence work creates opportunities for men to take responsibility for their behaviour and offers support for men to identify and make non-violent choices in their current and future relationships.
4. Risk assessment and risk management processes are robust and align with the jurisdiction's required risk assessment and management frameworks.

I will comply with the minimum practice standards outlined in *Men's Behaviour Change Group Work: A manual for quality practice*<sup>2</sup> when conducting any group work with men who use family violence and in all other specialist men's family violence work, insofar as they apply.

*NTV will monitor members' compliance with the Rules, guiding principles and the minimum practice standards. Complaints received by NTV about any member's non-compliance will be investigated and their membership reviewed by the NTV Board of Directors.*
